“THE IROQUOIS”

Located on the east shore of Conneaut Lake, the Iroquois Boating and Fishing Club was chartered October 10, 1887 and remains a continuing, active, viable Club dedicated to providing a social atmosphere for the enjoyment of its members.

The original clubhouse opened on September 27, 1888, and numerous improvements and minor expansions were made in the following years. The entire club had to be re-built after a disastrous fire destroyed the original on September 30, 1928. A new lounge was officially opened in 1973. The dining room was totally renovated in 1986, and the kitchen completely updated in 1989. The Club has maintained a décor and a character that is the envy of many supposedly wealthier and more sophisticated Clubs.

Social activities of the Club are usually scheduled at the end of the preceding year. The events are outlined in the Year Book along with the By-Laws and a listing of members and officers. Usually during the season “special” activities are added. These are usually advertised in the Bulletins, sometimes called “Smoke Signals”.

Historically, five annual events highlight the year’s affairs.

1. Opening Special Night – Usually held mid March
2. The ClamBake – Usually held late September or early October. The first was held October 12, 1895.
3. The Annual Founder’s Day Meeting – Usually held in October. Members Only.
4. Fall Formal (Black Tie or Dark Suit) – Usually held in November.
5. The IBC South Lawn Sizzle is held in June.

The Iroquois Club was founded by a group of forty men from Meadville, Pennsylvania. Over the years the membership has increased to the present 275 active members. Other membership classifications include Associate, Honorary, Luncheon and Honorary Associates. Along with this expansion have come members from Conneaut Lake, Greenville, Sharon, and Oil City.

Most people take pride in their membership in the Club’s facilities. Boat docks are provided for members at a nominal cost and the purpose of the Club is devoted entirely for the benefit and the enjoyment of its members.

The Iroquois can be likened to a gem to be valued and enjoyed.

HOUSE RULES

The Club is open for dining Tuesday through Sunday, June 1 through Labor Day. From March 11 to May 29 and Labor Day to December 31st, the Club is open Wednesday evening through Sunday. With prior arrangements, the Club can be available to the membership as needed.

The laws of the Commonwealth of Pennsylvania require that members register all guests in the guest book of the Club. **All members are urged to comply.**

The hours of serving: Luncheon served from 12 noon until 2 p.m.; Dinners served from 5 p.m. until 9 p.m., Friday and Saturday from 5 p.m. until 10 p.m., Sunday 12 noon until 8 p.m. Please make reservations when possible. **(Courtesy – Anyone expecting to dine after 9 p.m., please call.)**

Jackets shall be the accepted wear for members and their guests for dinner and buffets in the main dining room. Casual attire will be permitted everywhere in the Club but the main dining room (with the exception of special nights, family nights and luncheons). Shorts of appropriate length, slacks, jeans, informal shirts are acceptable in the lounge, casual dining area, patio and Room #30. Swimsuit attire is not acceptable anywhere in the Club except "Room #30" and dressing rooms. **Shoes must be worn anytime inside the Clubhouse** (members shall maintain the "dignity" of the Club). Hats for gentlemen are not acceptable anywhere in the Club.

Club facilities are available to the spouse or the member and their children as long as such children are dependent upon and actually reside with such member.

Children are not permitted on the Club grounds after 9 p.m. unless specifically accompanied by a parent member or member chaperone. Children are not permitted in the bar at any time unless accompanied by a parent member or member chaperone. **All members are urged to comply.**

The Club will not be responsible for any loss of, or damage to, personal property of members and guests. All property is brought on the premises at the owner's risk.

Members will be held responsible for any damage to Club property or equipment incurred by them or their guests, and will be billed for the replacement or repair of such damage.

Members and guests in bathing attire may not use the door into the dining area in going to and from the beach or boating area.

Dogs will not be permitted in the Clubhouse, on the patio, or on the beach area either with or without a leash. Dogs may be leashed in the rear of the Club property near the barn during the member's or his guest's visit to the Club. **(The laws of the Commonwealth of Pennsylvania are strict in this respect. Members are urged to comply.)**

The use of motor scooters, motorbikes, and motorcycles are restricted on all Club property except those vehicles may enter upon the grounds and park in the proper designated parking areas.

Picnics must be confined to the picnic area. No picnics will be allowed on the patio in front of the dining room. **Alcoholic beverages may not be carried onto the grounds.** All such beverages must be purchased through the Club.

Solicitation will not be permitted on Club grounds.

The quarterly minimum adopted in 1980 covers three (3) quarters; the first quarter beginning with the opening date in March and running through June 30; the second quarter running from July 1 through September 30; the last quarter running from October 1 through the closing date in December. This minimum is \$200.00 per quarter for three quarters for food and beverage service on the premises, exclusive of tax and service charge. A member who resides outside of a 200-mile radius of the Club for four full months during the operating season can elect to pay the annual prevailing minimum in a single payment by March 1 and therefore not be subject to a quarterly minimum.

All cancellations for regular scheduled Club functions must be made at least 24 hours in advance of the party or the member will be charged.

Pennsylvania Liquor Control Board law prohibits the sale of any liquor, malt or brewed beverage for consumption off the licensed premises. **Members are urged to comply.**

Members must not knowingly invite, accompany, or facilitate the presence of a person on IBC property, including the beach, who has been suspended, expelled or otherwise banned from the club by action of the board or the manager.

GROUND RULES

All sails on Sunfish and Hobie Cats must come down whenever boats are beached. **NO EXCEPTIONS.**

All members and their immediate guests are required to register their names with the WAIT STAFF on duty.



DOCK RULES

SPACE ASSIGNMENT

Dock tenants from the preceding year have the first right to their previous slip. The Club requests that you notify them prior to January 1 if you will not be retaining your slip for the new year.

Applications for the remaining available slips will be sent to those members on the dock waiting list. New dock tenants will be assigned slips with strict adherence to their position on the waiting list.

Dock tenants may trade slip assignments only if agreed upon by the Board of Trustees.

Dock space assignment is for the sole account of the member. No subletting will be permitted.

DOCK RESTRICTIONS

Physical alterations to the docks without prior approval will not be permitted.

Proper tie lines must be used. The Club is not responsible for damage due to improper tying.

1. Courtesy docking is permitted on the west side of the docks.

BOAT RESTRICTIONS

1. Power boats are limited in size to 21 ½ ft. long and 7 ½ ft. wide. Power boats larger in size will be subject to considerations by the Building and Grounds Committee and the Board of Directors.

2. Power boats must have properly fitting covers in good repair.

3. Caution and good sportsmanship are for the benefit of all when operating boats of any kind in the dock area.

4. No additional sailboats permitted in power boat dock slips.

BY-LAWS
Revised October 17, 2012
TITLE I – MEETINGS

SECTION 1 – ANNUAL MEETING. The annual meeting of the Club members shall be held in October every year at a place designated by the Board of Trustees. The day of the meeting shall be known as Founder's Day. The Secretary shall mail a notice to all of the members, at their last known address, at least five days prior to the meeting and said notice shall contain a statement of the purpose for which the meeting is called.

SECTION 2 – ORDER OF BUSINESS. The order of business for the annual meeting shall be as follows:

- (a) Reading of the minutes of the last regular and special meeting.
- (b) President's Report.
- (c) Secretary's Report.
- (d) Treasurer's Report.
- (e) Committee Reports.
- (f) Unfinished Business.
- (g) New Business. Establishment of Dues and Membership Fees.
- (h) Nomination and Election of Trustees and President.
- (i) Motion for approval of Board of Trustees actions during the past year
- (j) Adjournment.

SECTION 3 – QUORUM. The majority of the members present shall constitute a quorum for the purpose of transacting business at meetings of the membership.

SECTION 4 – SPECIAL MEETINGS. Upon the written request of twenty members of the Club, or at the request of a majority of the members of the Board of Trustees, the President, or in their absence the Vice President, shall call a special meeting to the Club Members, notice of which shall be mailed to each member at their last known address by the Secretary at least five days prior to the date of the said meeting. All requests for the calling of special meetings of the Members shall state the object or objects for which such meeting is requested, and said object or objects shall also be stated in the notice mailed to Members. No business shall be transacted at any special meeting except as specified in the notice thereof. The majority of the members present shall constitute a quorum at any special meeting of the members of the corporation.

SECTION 5 – VOTING. At any meeting of the Membership of the Club, any regular member, in good standing, may attend and vote in person. If absent they may not vote by proxy. Honorary members are also entitled to attend and vote in person.

TITLE II – OFFICERS

SECTION 1 – CLUB OFFICERS. The officers of the club shall be a President, a Vice President, a Secretary, and a Treasurer. The President shall be elected for a term of one year by themembers at the annual meeting and shall be a member of the Board of Trustees. No member shall be elected to the Office of President for more than two consecutive terms of one year each. The Vice President, the Secretary, the Treasurer, and if desired by the President, a Parliamentarian shall be appointed by the Board of Trustees at their first meeting following the annual election. The Vice President shall be a member of the Board of Trustees. The Secretary, the Treasurer, and the Parliamentarian need not be members of the Board of Trustees and shall be appointed for a term of one year or until their successors are duly appointed.

SECTION 2 – VACANCIES. All vacancies caused by the death or resignation of an officer or a member of the Board of Trustees shall be filled until the next annual meeting by a majority vote of the Board of Trustees.

SECTION 3 – DUTIES OF THE PRESIDENT. The President of the Club shall:

- (a) Preside at all meetings of the membership and at all meetings of the Board of Trustees.
- (b) Call special meetings of the members upon written request of twenty or more members or at the direction of the Board of Trustees.
- (c) Appointed such committees as they may deem expedient and as are necessary for the proper management of the Club. They shall serve ex-officio on all committees.
- (d) Perform any other duties prescribed by the by-laws.

SECTION 4 – DUTIES OF THE VICE PRESIDENT. It shall be the duty of the Vice President to discharge all of the duties of, and exercise all of the powers, of the President in their absence or disability.

SECTION 5 – DUTIES OF THE SECRETARY. The Secretary shall:

- (a) Keep a record of the proceedings of the meetings of the membership and of the Board of Trustees.
- (b) Give due notice of all membership and Board of Trustees meetings.
- (c) Perform such other duties as are prescribed by these By-Laws or designated by the Board of Trustees.

SECTION 6 – DUTIES OF THE TREASURER. The Treasurer shall:

- (a) Present a written report of the financial condition of the Club at the annual meeting.
- (b) Perform such other duties as are prescribed by these By-Laws or designated by the Board of Trustees.

SECTION 7 – DUTIES OF THE PARLIAMENTARIAN. The Parliamentarian shall:

- (a) Interpret the By-Laws, as required, for the membership and/or the Board of Trustees.
- (b) Give any needed advice on parliamentary procedures following Robert's Rules of Order.

SECTION 8 – ABSENCE OF OFFICERS. In the event that the Treasurer or the Secretary should become temporarily absent or incapable of serving, the Board of Trustees may appoint an assistant Secretary and/or an assistant Treasurer to carry on the duties of the officers involved until such times as the Secretary and/or the Treasurer shall be present and able to serve.

TITLE III – BOARD OF TRUSTEES

SECTION 1 – MAKEUP OF THE BOARD OF TRUSTEES. The Board of Trustees shall consist of eight members, one of whom shall be the President. Three members of the Board of Trustees shall be elected at the annual meeting each year and serve for a term of two years or until their successors are duly elected. The immediate Past President shall be a member of the Board of Trustees making a total of eight voting members on the Board of Trustees.

SECTION 2 – VACANCY. Any vacancy occurring on the Board of Trustees, shall be filled by a majority vote of the remaining trustees, and said Trustee shall serve until the next annual meeting at which time the remainder of any unexpired term will be filled by a vote of membership. If the immediate Past President is unable to serve, their place will remain vacant.

SECTION 3 – DUTIES OF THE BOARD OF TRUSTEES. The Board of Trustees shall:

- (a) Have supervision and control of the affairs, monies, and property of the club.
- (b) Have the full power to carry out the corporate objectives of the Club according to its charter, except where otherwise provided by these By-Laws.
- (c) Make all necessary purchases and contracts. Routine operational purchase authority may be delegated by the Board of Trustees to the Club Manager.
- (d) Have power to contract debts and execute notes or mortgages, provided, however, that the amount of such indebtedness shall not exceed the sum of \$75,000 per calendar year unless authorized at a membership meeting, but renewals may be executed without such authority.
- (e) Have authority to make such rules and regulations as it deems necessary for the proper management of the Club.
- (f) Meet at least every two months for the transaction of Club business.
- (g) Not sell, lease or otherwise dispose of any real estate unless and until a resolution authorizing the same shall have been approved by a majority of the members of the Club present at a regular or special meeting duly convened, upon proper notice of the purpose of the meeting.

SECTION 4 – QUORUM. Trustees shall be given five days notice prior to any Board meeting, and a quorum of the Board of Trustees shall be five members thereof. In lieu of the five days notice, the Board of Trustees may set a regular date for meetings.

SECTION 5 – ABSENCE. If a Trustee shall absent themselves from three consecutive meetings of the Board without presenting, at its next meeting, a satisfactory explanation for their absence, the Trustee may declare their place vacant and may elect a Trustee to fill the vacancy for the unexpired term and until the next annual meeting at which time the membership shall elect a member for the remainder of any unexpired term.

SECTION 6 – EMPLOYEES. Except as otherwise provided in these By-Laws, the Board of trustees shall employ and fix the compensation for all regular salaried employees of the Club. The authority to employ and fix the compensation for casual and/or hourly employees may be delegated by the Board of Trustees to the Club Manager.

SECTION 7 – PERSONAL LIABILITY OF DIRECTORS.

(a) A trustee shall not be personally liable, as such, for monetary damages (including without limitation, any judgment, amount paid in settlement, penalty, punitive damages or expense of any nature, including, without limitation, attorneys' fees and disbursements) for any action taken, or any failure to take any action unless:

(b) The trustee has breached or failed to perform the duties of his or her office under Subchapter 17B of the Business Corporation law (or any successor provision); and

(i) The breach or failure to perform constitutes self dealing, willfull misconduct or recklessness.

(c) The provisions of paragraph (a) shall not apply to the responsibility or liability of a trustee pursuant to any criminal statute, or the liability of a trustee for the payment of taxes pursuant to local, state or federal law.

TITLE IV – AUDITORS

SECTION 1 – BOOKS OF ACCOUNT. The Board of Trustees shall make available to the members on or before April first of each year, an internally prepared written review of the Club's books of account, and such review shall represent the Club's financial activity during the prior year. The Board of Trustees, at their discretion, may request that a Certified Public Accountant be engaged to prepare a Reviewed Financial Statement or an Audited Financial Statement if so deemed necessary by the Board.

TITLE V – MEMBERSHIP

SECTION 1 – AUTHORIZED LIMIT. Persons twenty-one years of age and over shall be eligible for membership, and the membership of the Club shall be limited to two hundred seventy-five members, excluding Social Associate, Honorary, Honorary Associate, and Luncheon members as provided hereafter. No membership shall be transferable.

SECTION 2 – APPLICATION, APPROVAL, OR REJECTION. Application for membership shall be made in writing, on forms provided by the Club, to the Membership Committee and sponsored by at least two members of the Club. The Membership Committee shall then submit the application to the Board of Trustees with the committee's recommendations. The Board of Trustees shall vote on the application by written ballot, if more than one Trustee disapproves an application, then the Membership Chairman shall notify the sponsoring members that the application has been rejected by the Board of Trustees and that the applicant's name is being removed from the waiting list. In such case, it is the responsibility of the sponsoring members to notify the applicant. If the Board of Trustees approves the application, then the Secretary shall notify the members by mail of such application, at least ten days prior to final action

theron by the Board of Trustees. Accompanying such membership notification shall be a ballot supplied by the Secretary which shall be used by the members to indicate their disapproval of the applicant. Only those ballots which are signed by a member shall be counted as a vote for disapproval. Negative ballots returned to the Secretary by five members within ten days shall be equivalent to a rejection. In case of a rejection of an applicant, such candidate shall not again be proposed for membership for a period of one year.

SECTION 3 – NOTIFICATION. An applicant elected shall be forthwith notified of their election by the Secretary who will also notify the sponsors. At the same time the Secretary will furnish the applicant with a copy of the By-Laws and collect from them the amount then due as membership fee. If the applicant is rejected, the Secretary shall notify the sponsors, whose responsibility is to immediately notify the applicant.

SECTION 4 – SOCIAL MEMBERS. There shall be also a class of members known as Social members, which shall consist of the spouse of members. A Social member shall have no right to vote or to attend membership meetings, and their membership will automatically terminate upon the resignation or expulsion from the Club of the member.

SECTION 5 – ASSOCIATE MEMBERS. Upon the death of a member in good standing, the privileges of the Club may be accorded to the surviving spouse and minor children upon the vote of the Board of Trustees and upon the condition that they pay fifty percent of the annual Club dues, and assessments fixed for the regular Club members. They shall be known as an Associate Member, but may not attend meeting or vote.

SECTION 6 – HONORARY MEMBERS. There shall be a class of members known as Honorary Members, who are those members who have been active members for 35 years or more or who were previously classified as LIFE members. They shall not be required to pay dues or special assessments. They shall have all of the rights and privileges of regular members.

SECTION 7 – HONORARY ASSOCIATE MEMBERS. There shall be a class of members known as Honorary Associate members which shall include the surviving spouses of the deceased Honorary members, and present associate members whose deceased spouse became active members prior to the past 35 year period. They shall not be required to pay dues or assessments.

SECTION 8 – LUNCHEON MEMBERS. There shall be a class of members known as Luncheon Members, which class shall consist of persons twenty-one years of age and over. Luncheon members shall have use of the Club house during luncheon hours on days of the weeks and at times as determined by the Board of Trustees. Luncheon members shall also have limited use of other Club facilities as

determined by the Board of Trustees. The membership fee, dues and assessments for Luncheon members shall be set annually. Luncheon members shall not be entitled to vote.

SECTION 9 – CHILDREN. Children, under twenty-five years of age, of Regular, Associate, Honorary, Luncheon and Honorary Associate members in good standing may have and enjoy the privileges of the Club subject to such rules and regulations as the Board of Trustees may provide.

SECTION 10 – REINSTATEMENT. Previous regular members in good standing who had to resign because of moving from the area and who had returned and again established legal residence in the area, may apply for regular membership, and if approved by the Board of Trustees, shall pay a reinstatement fee equal to fifty percent of the current annual dues plus all applicable taxes. Board of Trustees approval is contingent upon the availability of membership under TITLE IV – SECTION 1 of these By-Laws.

TITLE VI – NON-PAYMENT OF MEMBERSHIP FEE

SECTION 1 – Any person who shall receive notice of his/her election and shall not within thirty days of the date of said notice make payment in full of the membership fee and dues, may at the option of the Board of Trustees, forfeit all rights acquired by his/her election. Installment payments of membership fees must be previously approved by the Board of Trustees.

SECTION 2 – In the event the Board of Trustees has approved an installment payment plan for a person's payment of the membership fee and dues, each installment must be paid within thirty (30) days of the date of the installment billing notice. In the event the installment is not paid within thirty (30) days of the date of said notice, the board of Trustees may at its option terminate all rights and privileges of membership of that person, and all previously paid installments of membership fee and dues shall thereupon be forfeited.

TITLE VII – PAYMENT OF MEMBERSHIP FEE

SECTION 1 – MEMBERSHIP FEE. At each annual meeting, the members shall determine and fix the amount of the membership fee for the ensuing year and the terms of payment thereof; and upon failure to take such action, the price and terms fixed for the preceding year shall continue until changed at an annual meeting.

SECTION 2 – RIGHTS AND PRIVILEGES. Each person who has paid his/her membership fee and dues in full shall be entitled to all of the rights and privileges of membership including the right to attend and vote at the meetings of the membership.

If an installment payment plan for the membership fee and dues is approved by the Board of Trustees for a person and the plan payments are current, that person shall be entitled to rights and privileges of membership. Upon that person's payment of his/her membership fee and dues in full that person shall also be entitled to attend and vote at the meetings of the membership.

TITLE VIII – DUES, ASSESSMENTS AND GENERAL ACCOUNTS

SECTION 1 – CLUB DUES. Each member and each person who has paid an installment payment of membership fee and each Associate member shall be liable for the payment of the annual Club dues and assessments. The amount of such dues and assessments shall be fixed at the annual or special meetings of the members. In the event that the members fail to take action on dues at the annual meeting, then the dues for the preceding year shall continue until changed at an annual or special meeting.

SECTION 2 – PAYMENT OF DUES AND ASSESSMENTS. Dues and assessments shall be billed annually on the first day of January of each year. All dues and assessments shall be due and payable in full by March 1st of that year unless a member intending to resign gives written notice of his/her intention to resign to the President or Treasurer of the Board of Trustees prior to March 1st. **If a member fails to pay dues by March 1st, his or her name shall be posted in a conspicuous place in the Club House and unless paid on or before May 1st, or unless such default be accounted for to the satisfaction of the Board of Trustees and arrangements satisfactory to the said Board of Trustees be made for the payment of such delinquent dues, he or she shall thereupon cease to be a member but shall nevertheless continue to be liable for the payment of said delinquent dues and any other indebtedness owing to the Club, including assessments.** In addition thereto, said individual shall forfeit all interest in the general property of the Club, both real and personal. The Secretary shall notify the members of such posting suspension, or expulsion. When suspended, special action of the Trustees shall be required to reinstate a member to full privileges of membership and then only upon full payment of past indebtedness. If a member is elected after August 1st of any year, one half of the regular dues shall be payable for that year.

SECTION 3 – BILLS. Bills of Members, other than dues or assessments, shall be settled monthly. (Bills include all house charges, docking or other fees, and charges at any other Club having a reciprocal agreement with the Club.) Such bills shall be considered past due at the expiration of one month from the date of mailing. The names of members having past due accounts may be posted in the Club House if the Board of Trustees so elect. If accounts are not paid within fifteen days after becoming past due, the member shall become automatically suspended until such bill is paid in full. If not paid by January first of the following year the Board of Trustees may expel the member. The Secretary shall notify the member of such posting, suspension or expulsion.

At the discretion of the Board of Trustees, a late charge may be added to the unpaid balances.

SECTION 4 – MILITARY SERVICE. The Board of trustees, at its discretion, may suspend the dues of any member in the Military Service.

TITLE IX – TERMINATION OF MEMBERSHIP

SECTION 1 – Membership shall terminate:

- (a) Upon acceptance in writing of the Board of Trustees of the resignation of a member.
- (b) Upon the death of a member.
- (c) Upon the non-payment of dues, assessments, or indebtedness as herein before provided.
- (d) Upon expulsion by the Board of Trustees as provided in Title XII hereof

TITLE X – CLUB PROPERTY

SECTION 1 – All damage to the Club property shall be paid for by any member willfully or negligently causing same. Member are liable for their guests.

TITLE XI – GUESTS

SECTION 1 – NON-MEMBERS AS GUESTS. Non-members living within a radius of fifty miles of the Club House, shall not be guests or visitors at the Club more than once in any one calendar month. Said restrictions will not apply to large private parties sponsored by a member of the Club.

SECTION 2 – GUESTS. No member may introduce as their guest or guests anyone who is not in fact a bona fide guest, and said member shall assume and pay for all charges incurred by their guest or guests. No

guests may be in the Club House or the Club grounds unless accompanied by a member.

SECTION 3 – GUESTS. The guest limitation set forth in Section 2 shall not apply to Luncheon members. Such members shall be permitted to invite guest to the Club to any guest who does not observe the rules of decorum set for the Club members and guests.

SECTION 4 – GUESTS. The Club officers, trustees and the Club manager, reserve the right to deny use of the Club to any guest who does not observe the rules of decorum set for the Club members and guests.

TITLE XII – DEPARTMENT

SECTION 1 – For conduct unbecoming a member, for destruction of Club property, for violation of these By-Laws, or House rules, any member, after a hearing before the Board of Trustees, may be fined, suspended, or expelled from the Club at the sole discretion of the Board of Trustees.

TITLE XIII – SINKING FUND

SECTION 1 – A separate fund is hereby created to be known as the sinking fund into which all membership fees and assessments are paid. Said sinking funds shall be used only for capital improvements to the Club property as may be directed and authorized by the Board of Trustees or by members at a regular or special meeting called for said purpose.

TITLE XIV – NOTICES

SECTION 1 – Service of all notices required by these By-Laws shall be written or printed notices sent to the last known post office address of a member. Notices requiring posting shall be displayed in a prominent place in the Club House.

TITLE XV – ORDER OF BUSINESS AT TRUSTEES' MEETINGS

SECTION 1 – The order of business at the Trustees' meetings shall be as follows:

- (a) Roll call.
- (b) Reading of the minutes of last regular and special meetings.
- (c) Report of the Club Manager.
- (d) Report of the Secretary.

- (e) Report of the Treasurer.
- (f) Report of Committees.
- (g) Presentation of bills.
- (h) Communications.
- (i) Unfinished business.
- (j) New business.
- (k) Proposal and election of members.
- (l) President's comments and summary.
- (m) Adjournment.

TITLE XVI – HOUSE RULES

SECTION 1 – The Board of Trustees shall make suitable house rules and shall from time to time revise same; and when said rules and/or regulations are posted in the Club House or mailed to the members they shall be in force and binding upon the members.

TITLE XVII – NOMINATING COMMITTEES

SECTION 1 – APPOINTMENT OF NOMINATION COMMITTEE. At least thirty days prior to the annual meeting the President, with the approval of the Board of Trustees, shall appoint a nominating committee, consisting of not less than three members. Said Committee shall present, at the annual meeting, one member to serve as a Trustee for each vacancy to be filled on the Board of Trustees. The Secretary shall list on the notice of the annual meeting the nominees for President and for the Board of Trustees.

SECTION 2 – NOMINATIONS FROM THE FLOOR. Nominations for President and persons to serve as Trustees may also be made from the floor at the annual meeting.

TITLE XVIII – MEMBERSHIP COMMITTEE

SECTION 1 – APPOINTMENT OF MEMBERSHIP COMMITTEE. At the first meeting of the Board of Trustees following the annual meeting, the President shall appoint a Membership Committee consisting of not less than three members of the Club. At least one member of the Committee shall be a Trustee and shall serve as Chairman of the Membership Committee. Appointment of members to this committee should be with the agreement of its chairman.

SECTION 2 – DUTIES OF MEMBERSHIP COMMITTEE. The Membership Committee shall screen all applications for membership and report on same, with recommendations, to the Board of Trustees. The Committee shall function with rules approved by the Board of Trustees.

TITLE XIX – HOUSE COMMITTEE

SECTION 1 – APPOINTMENT OF THE HOUSE COMMITTEE. At the first meeting of the Board of Trustees, following the annual meeting, the President shall appoint a House Committee consisting of not less than three members of the Club. At least one member of said committee shall be a Trustee and shall be its Chairman. Appointment of members of the Committee should be with the agreement of its Chairman.

SECTION 2 – DUTIES OF THE HOUSE COMMITTEE. The House Committee shall have supervision of all of the activities of the Club **except** those activities that are supervised by other appointed committees. They shall supervise the Club Manager's activities including the Kitchen and the Bar areas.

TITLE XX – BUILDING AND GROUNDS COMMITTEE

SECTION 1 – APPOINTMENT OF BUILDING AND GROUNDS COMMITTEE. At the first meeting of the Board of Trustees, after the annual meeting, the President shall appoint a Building and Grounds Committee consisting of not less than three members of the Club. One member of said committee shall be a Trustee and shall be its Chairman. Appointment of members of the Committee should be with the agreement of its Chairman.

SECTION 2 – DUTIES OF BUILDING AND GROUNDS COMMITTEE. The Building and Grounds Committee shall be responsible for the condition of both the buildings and the grounds, including the dock, beach and boating areas. They shall prepare estimates for any required maintenance item for presentation and approval of the Board of Trustees. In case of emergencies they are authorized to expend reasonable sums to insure the preservation of Club property. This authorization assumes that the expenditures so made, will be presented to the Board of Trustees at the first available meeting for approval.

TITLE XXI – SOCIAL COMMITTEE

SECTION 1 – APPOINTMENT OF SOCIAL COMMITTEE. At the first meeting of the Board of Trustees, following the annual meeting, the President shall appoint a Social Committee consisting of not less than three members of the Club. At least one member of said committee shall be a Trustee and shall serve as Chairman of the Social Committee. Appointment of members of this Committee shall be with the agreement of its Chairman.

SECTION 2 – DUTIES OF THE SOCIAL COMMITTEE. The Social Committee will have charge of all social activities of the Club, except for those activities specifically assigned to a Special Committee. They will be responsible for the appointment of Dance Committee for specific events approved by the board of Trustees. They will also be responsible for special entertainment. All expenditures for social activities must have prior approval from the Board of Trustees.

TITLE XXII – COMMITTEES-GENERAL

SECTION 1 – SPECIAL COMMITTEES. The President may appoint such special committees as may be expedient to proper management of the Club. In such cases he should provide the Chairman of the Special Committee with a brief statement of the duties of said committee. In cases of possible overlap with regular standing committees of the Club, the President should give a copy of the statement of duties of the special committee to the standing committee that may be affected.

SECTION 2 – The President serves ex-officio on all committees of the Club.
